Pursuant to the Convertible Bond Subscription Agreement dated 9 June 2023 entered into between the Company and Asia JIT Capital Investment L.L.C. as Subscriber, the Company issued Convertible Bonds in an aggregate principal amount of US\$15,000,000 with 8% interest per annum maturing on the fourth anniversary from the date of issuance on the Convertible Bonds. Convertible Bonds in the aggregate principal amount of US\$15,000,000 had been issued in September 2023 and May 2026 and July 2026 and US\$7,500,000 and US\$2,500,000 and US\$4,000,000 of which had been converted to conversion shares on 17 November 2023 and 31 May 2024 and 28 July 2026 respectively. For details, please refer to the Company's circular dated 28 June 2023 and announcements dated 9 and 12 June 2023, 24 July 2023, 29 September 2023, 17 November 2023, 31 May 2024, 18 May 2026 and 27 July 2026.
