	(c) subject to the Listing Committee having granted the listing of, and permission to deal in the Capitalisation Shares, the Directors be and are hereby granted with a specific mandate which shall entitle the Directors to exercise all the powers of the Company to issue and allot up to 50,000,000 Capitalisation Shares to Synergy Green, on and subject to the respective terms and conditions of the Capitalisation Agreement, provided that the Specific Mandate shall be in addition to, and shall not prejudice or revoke any general or specific mandate(s) which has/have been granted or may be granted from time to time to the Directors prior to the passing of this resolution.
